Before me \_\_\_\_\_, a \_\_\_\_\_ Judge in and for said County personally came Corporal Matthew Woelk who, being duly sworn, deposes and says that between the dates of January, 2017 A.D and April, 2017 A.D in the County aforesaid one Toop, Brendan William, a white male, date of birth November 30, 1980, height: 5'11", Social Security number \_\_\_\_\_ Social Security Florida Driver's License number T100 079 80 430 0, brown hair, with a residency 2739 N Chamberlain Blvd North Port, FL 34286. Toop, Brendan William did have knowledge of and did commit the crime of Sexual Battery by person in custodial authority victim < 18 yoa.

All of the aforementioned charges did occur within the jurisdiction of Punta Gorda, Charlotte County Florida.

On 12/23/2019 the Punta Gorda Police Department dispatch received a notification from Fortify reference a Charlotte County High School teacher, Brendan Toop. The notification stated that there were concerning messages sent from Mr. Toop to a previous student of Charlotte High, \_\_\_\_\_ Sex \_\_\_\_\_ Sex Crime Due to the messages that \_\_\_\_\_ Sex Crime posted, a police investigation was initiated.

On 12/27/2019 the Charlotte County Sheriff's Office received two tips from two former students that attended Charlotte High School which is located at 1250 Cooper St, Punta Gorda FL 33950. The tips alleged that a teacher of the school, identified as Brendan Toop, had sexual encounters with each of the student's separately during the 2016 and 2017 school years. During the alleged encounters the students aged from 16 and 17 years old while Mr. Toop's age was 34 years old. It was later learned that the tips came from \_\_\_\_\_ Marsys Law

On 12/29/2019 the Charlotte County Sheriff's Office received another tip from \_\_\_\_\_ Sex Crime also reference an inappropriate relationship between Mr. Toop and a student. On the tip, \_\_\_\_\_ Sex Crime Victims stated that in 2016-2017 she attended Charlotte High school and was a friend to a female that received text messages from Branden Toop. It was later learned that the friend that \_\_\_\_\_ Sex Crime Victims referred to was \_\_\_\_\_ Marsys Law

On 12/30/2019 Detective Woelk made contact with \_\_\_\_\_ Marsys Law via land line. Upon asking \_\_\_\_\_ Marsys Law if she would be willing to come to the Police Department to provide a recorded statement, \_\_\_\_\_ Marsys Law stated yes. When Detective Woelk asked \_\_\_\_\_ Marsys Law when she last had contact with Mr. Toop, \_\_\_\_\_ Marsys Law stated a few days ago. \_\_\_\_\_ Marsys Law further stated that she had messaged him asking him why he had deleted his Snap Chat account in hopes of getting him to message about their past relationship. \_\_\_\_\_ Marsys Law stated that Mr. Toop replied by saying that he

had been advised to speak to no one and to delete all of his social media. It is currently unknown who suggested this to Mr. Toop.

On 1/02/2020 Marsys Law came to the police department to provide her statement. Marsys Law stated that between the months of January 2017 and April of 2017 she and Mr. Toop messaged each other. Marsys Law stated that she was 17 years old at the time and Mr. Toop was her 12<sup>th</sup> grade government and economics teacher. Marsys Law stated that she and Mr. Toop first started messaging each other through the Remind App. Marsys Law stated that their conversations consisted of school and non-school related matters. Marsys Law further stated that she also discussed an issue that she had at the school. Marsys Law explained by saying that she had been suspended after she had been assaulted by another student. Marsys Law stated that she discussed the issue with Mr. Toop and told him how she didn't trust the school because she didn't agree with how the situation was handled. Detective Woelk later learned that the Remind app was a program used by the school where teachers could contact students and vice versa for school related matters. Marsys Law stated that after the Remind app, she and Mr. Toop exchanged personal phone numbers where they texted each other frequently.

Marsys Law stated that while she and Mr. Toop messaged each other through text messages, Mr. Toop's messages became flirtatious in nature. Marsys Law explained this by stating that Mr. Toop would send messages that said things like, she was too beautiful to be single. Marsys Law further stated that Mr. Toop would attempt to get compliments about himself from her. Marsys Law stated that, not long after receiving his phone number, they added each other on Snap Chat. Marsys Law stated that as the conversations continued on Snap Chat, Mr. Toop continued to be flirtatious in his messages. Marsys Law further stated that along with flirtatious messages, Mr. Toop also sent her a picture of himself in his red boxer briefs.

When Detective Woelk asked Marsys Law how many times she and Mr. Toop would message each other, Marsys Law stated that they would send messages back and forth throughout the entire day of school. When asked if Mr. Toop ever asked to meet her outside of school, Marsys Law stated yes. Marsys Law further stated that Mr. Toop would message her after his hockey games and ask her if she wanted to meet and have sex. Marsys Law stated that she never did meet with him after school prior to graduating.

Marsys Law stated that after continuing to message each other, one day during lunch Mr. Toop messaged her and told her that he was turned on. Marsys Law stated that after the message, they messaged about meeting each other in his classroom. Marsys Law stated that upon entering Mr. Toop's classroom, Mr. Toop was sitting at his desk and appeared to be nervous. Marsys Law explained that Mr. Toop's leg was shaking. Marsys Law stated that shortly thereafter, Mr. Toop asked her if she wanted to see his closet. Marsys Law stated that after Mr. Toop locked the door to his classroom, they both walked into the classroom closet.

Marsys Law stated that while in the closet, she and Mr. Toop began to kiss. Marsys Law stated that next they talked about her giving him oral sex. Marsys Law further stated that she was scared what would happen if she didn't perform oral sex on Mr. Toop because she liked him and she wanted him to like her. Marsys Law stated that she then gave Mr. Toop oral sex for several minutes until she stopped because she was afraid. When Detective Woelk asked Marsys Law to better explain why she was scared, Marsys Law stated that she was fearful of getting caught and scared about what would happen between Mr. Toop and her.

Marsys Law stated that after she stopped the oral sex, she attempted to leave the closet. Marsys Law stated that as she walked out of the closet, Mr. Toop pulled her back in by her hips while

he kissed her neck. Marsys Law stated that Mr. Toop then bent her over a desk inside the closet and began thrusting himself against her for about 5 to 10 minutes until he stopped. When asked if they had intercourse, Marsys Law stated no. Marsys Law stated that they both had their clothes on during the thrusting and that Mr. Toop was just thrusting his pelvis against her. Marsys Law stated that after Mr. Toop stopped, they both exited the closet and sat apart from each other in the classroom. Marsys Law stated that when Mr. Toop asked her if she was 17, she stated that she told him she was. Marsys Law stated that Mr. Toop then unlocked the classroom door and she left.

Marsys Law stated that after the incident in the closet, Mar stopped talking to Mr. Toop. Marsys Law further stated that after she stopped talking to him, Mr. Toop failed to enter one of her grades. Marsys Law stated that she felt that Mr. Toop did this because she stopped talking to him.

When Detective Woelk asked Marsys Law to describe Mr. Toop's classroom and closet, Mar Marsys Law stated that upon entering the classroom, the closet was to the right. Mar further stated that the closet's interior was long and that Mr. Toop had a desk and filing cabinets within it. This was later verified when Detective Woelk and Detective Meddaugh went to the high school and viewed Mr. Toop's classroom.

When Detective Woelk asked Marsys Law if she wanted to pursue criminal charges against Mr. Toop, Marsys Law first stated that, since she didn't have any evidence, she didn't know if she could. She added that she would pursue charges against him if she could.

After speaking with Marsys Law Detective Woelk received her permission to have the contents of her phone downloaded in an attempt to find traces of the texts and dates of the texts between herself and Mr. Toop. Detective Woelk took the phone to the Charlotte County Sheriff's Office where Detective Fiorini downloaded its contents. Detective Fiorino works in the computer crimes unit.

Later, upon reviewing the contents of Marsys Law's phone, Detective Woelk found that there were 284 I Phone messages sent between them. Within the 284 messages, Detective Woelk found several suspicious messages. For example, when Marsys Law asks Mr. Toop if she was his favorite student, Mr. Toop says no. When Marsys Law asks if she is his favorite anything, Mr. Toop replies; extra curriculars. Later on 4/10/2017 when Marsys Law tells Mr. Toop that she is sick, Mr. Toop tells her to keep her distance. Marsys Law replies by saying that she will not make out with him when she is sick.

Detective Woelk also viewed a chat conversation between Marsys Law and a female later identified as Marsys Law. Several times throughout their conversation, Marsys Law mentioned Mr. Toop and Marsys Law's relationship. Also within Marsys Law's phone Detective Woelk found two notes that Marsys Law had written to herself on 4/04/2017. The notes state; he was like dry humping me and I was so confused. Marsys Law also wrote; he's like you're a student and your 17 right? And I said yes. He's like omg I'm gonna go to jail. It was so hard not to say prison actually. Both comments corroborate statements made when she gave her recorded statement about the sexual encounter that she had in the closet with Mr. Toop.

Upon reviewing the messages sent between Marsys Law and Mr. Toop via the Remind app, Detective Woelk found that the messages began on 11/16/2016 and stopped on 1/22/2017. A total of 432 messages were sent between the two of them. The Remind messages consisted of school and non-school related matters. Detective Woelk also found that Marsys Law discussed the issue

that she had at the school. Marsys Law told Mr. Toop that she had been suspended after she had been assaulted by another student. Detective Woelk further found that on 1/21/2017 Marsys Law provided her personal phone number to Mr. Toop.

On 1/03/2020, due to the tip that Sex Crime provided to the Sheriff's Office on 12/29/2019, Detective Woelk made contact with her via land line. Upon being asked if she would provide a sworn statement, Marsys stated that she would. Sex Crime's statement was taken over the phone. Sex Crime stated that during her senior year, she became aware of messages that Mr. Toop was sending. Marsys Law stated that at the time both she and Marsys Law were 17 years old and both were seniors. Marsys Law stated that Mr. Toop initially began messaging Marsys Law via a school app (Remind) and then provided Marsys Law with his personal phone number. Marsys Law stated that Marsys Law allowed her to view some of the messages sent by Mr. Toop. Sex Crime Victims stated that the messages became more and more flirtatious by the day. Marsys Law stated that some of the messages sent by Mr. Toop consisted of comments that said "You're too beautiful to be single" and "I don't understand why you're so insecure" and "any guy would be lucky to have you." Sex Crime Victims also advised that Marsys Law had told her that Mr. Toop had sent a picture of himself in only his underwear. When Detective Woelk asked if she had ever seen any messages sent about Mr. Toop's wife, Sex Crime said yes. Sex Crime stated that she remembered that message saying that Mr. Toop and his wife would be separating soon. Sex Crime advised that she was not privy to any sexual relationship that Marsys Law and Mr. Toop were having.

On 1/04/2020 Marsys Law came to the police department to provide her statement. During the interview with Marsys Law she stated that in August of 2015 she started her senior year. Marsys Law stated that she was 16 years old at the time. Marsys Law added that she had Mr. Toop as a teacher for government and economics from the beginning. Marsys Law stated about two weeks after beginning the school year she got into trouble and police officers came to the school to speak with her. Marsys Law stated that Mr. Toop took notice of this and was very supportive towards her. Marsys Law stated that, since her Sex Crime Victims Marsys Law stated that initially Mr. Toop was one of her favorite teachers. Marsys Law stated that she and Mr. Toop would talk a lot at school about life matters.

Marsys Law stated that sometime in September of 2015 she and her friends started eating lunch in Mr. Toop's classroom since they did not want to be around other people. Marsys Law further stated that later she and her girlfriend Marsys Law would eat in the classroom's closet while Mr. Toop stayed in the classroom. Marsys Law stated that as time went on another friend, Marsys Law and Mr. Toop started eating their lunch in the closet as well. When Detective Woelk asked what kinds of conversations took place in the closet, Marsys Law advised that they would talk about school related gossip and about their sex lives. When Detective Woelk asked what Mr. Toop talked about while they were talking about their sex lives, Marsys Law stated that Mr. Toop would provide erotic suggestions about sexual positions. Detective Woelk was unable to make contact with either Sex Crime Victims to confirm Marsys Law statements about the conversations had in the closet during lunch.

Marsys Law stated that as time went on, she began leaving her belongings in Mr. Toop's room since she would pass his classroom. Marsys Law stated that this wasn't an issue since he allowed other students to do the same. Marsys Law further stated that after a short amount of time, Mr. Toop began moving her belongings into his closet because he said, they were in his way. Marsys Law stated that only her belongings were put into the closet and the other students' belongings left next to Mr. Toop's desk. Marsys Law stated that at the end of each day, she would go into the Mr. Toop's closet to retrieve her things.

Marsys Law stated that, after a short time of having to go into the closet for her things, Mr. Toop began following her into the closet. Marsys Law stated that on one occasion in either January or February of 2016, after Mr. Toop had followed her into the closet, Mr. Toop kissed her. Marsys Law stated that Mr. Toop continued to kiss her in the closet each day after school. Marsys Law stated that this lasted for about 3 weeks. When asked if she ever told anyone what was happening, Marsys Law stated no. Marsys Law added that, at the time, she was drinking heavily and that she had grown numb to what was happening.

Marsys Law stated that, after the three weeks of kissing, Mr. Toop followed her into the closet again, unzipped his pants, pushed her head down and stuck his penis in her mouth. Marsys Law stated that prior to the oral sex, she wanted to leave the closet but stated that Mr. Toop was blocking the doorway. Marsys Law stated that after about two minutes of oral sex, she pulled her head back, grabbed her things and ran out of the classroom.

Marsys Law stated that after the final incident in Mr. Toop's closet, she stopped leaving her belongings in Mr. Toop's room. Marsys Law stated that shortly thereafter, Mr. Toop began to not document her grades. Marsys Law explained by saying that a paper would be due at the end of each week. Marsys Law stated that although she did turn her paper in, Mr. Toop failed to enter her grade for the paper as he did for everyone else in the class. Marsys Law stated that since it was Mr. Toop's policy to only discuss grades before or after class, she would now be required to meet with Mr. Toop alone. Marsys Law stated that when she did meet with Mr. Toop about her grade, he would grab her breasts and buttocks.

When Detective Woelk asked Marsys Law if she and Mr. Toop had ever text messaged each other, Marsys Law stated that she did not have a phone during her senior year. She added however, that about a month after graduating, Mr. Toop found her on Snap Chat and they briefly messaged each other. Marsys Law added that in November of 2019 she messaged Mr. Toop on Snap Chat to confront him about what he had done to her. Marsys Law stated that Mr. Toop apologized for any pain that he caused and that he was depressed.

When Detective Woelk asked Marsys Law if she wanted to pursue criminal charges against Mr. Toop, Marsys Law stated no. She added however, that she would provide testimony in court against Mr. Toop.

On 01/08/2020 Detective Woelk made contact with Marsys Law via land line. Sex Crime stated that prior to the messages, she had friend requested Mr. Toop on Facebook. Sex Crime stated that it is a common practice where graduated students become friends with past teachers on Facebook.

Sex Crime stated that within minutes of the friend request, Mr. Toop messaged her. Sex Crime Victims added that although Mr. Toop did message her, he never accepted the friend request. Marsys Law stated that initially their conversations consisted of mostly politics. Sex Crime stated that as the conversation continued, Mr. Toop would randomly fish for compliments from her. Marsys Law stated that there was one thing that Mr. Toop had said that definitely made her feel uncomfortable.

Sex Crime stated that Mr. Toop had said something about being an old teacher who was creepily messaging her and trying to flirt. Sex Crime further stated that Mr. Toop would first say that she was seductive, then ask if he was making her feel uncomfortable. Sex Crime stated that when she said he was fine, Mr. Toop replied by saying, oh you think I'm fine (as in attractive). Sex Crime Victims stated that she simply meant that what he said was ok. Sex Crime stated that Mr. Toop would continue to change the meaning of her words to mimic a compliment about himself. Sex Crime Victims further stated that when Mr. Toop was flirting with her, she made a comment about him being

married with kids at which time Mr. Toop stated that he was married but he and his wife would probably be separating soon.

When Detective Woelk asked why, after so much time had passed, did she decide to post the messages from Mr. Toop, Sex Crime stated that it was because of two things. Sex Crime stated that the first reason was because of a Facebook post that Marsys Law had posted a few weeks prior to her post. Sex Crime stated that Marsys Law posted on Facebook that she was sexually assaulted by a teacher at Charlotte High. Sex Crime stated that after she read the post, even though Marsys Law did not provide the teachers name, she knew that the teacher was Mr. Toop. Sex Crime Victims stated that the second reason was that she learned that Mr. Toop was still a teacher at Charlotte High. Sex Crime stated that she was scared that Mr. Toop was still sexually assaulting students now.

When Detective Woelk asked Sex Crime if any other girls, other than Marsys Law had contacted her about Mr. Toop, Sex Crime stated yes. Sex Crime stated that she had also been contacted by Marsys Law. Sex Crime further stated that Marsys Law had contacted her separately. Sex Crime added that Marsys Law did not know much about Marsys Law prior to this. Upon being asked if there were any other girls that had contacted her, Sex Crime stated that there was another girl that had contacted her but wanted to remain anonymous. Sex Crime stated that the girl had text messages from Mr. Toop. Sex Crime added that the conversation between the girl and Mr. Toop happened in 2014. It should be noted that Sex Crime had provided the messages from the 2014 conversation when she gave her recorded statement. The girl's identity is currently unknown. The following are some of the messages that Mr. Toop sent to the unknown girl: "Are you drunk? You are calling yourself a slut and it seems like you wanna hook up, seems out of character. If you say so. That's what it seem like from this end. We could do hood rat things saying you are a low key slut. Right....so you are coming on to me?" The date on the messages is 6/06/2014 with Branden Toop's name listed on the top of the messages.

On 2/12/2020, Detective Woelk made contact with Sex Crime at her place of employ. Since Det. Woelk had found a conversation between Marsys Law and Sex Crime that referenced Mr. Toop, Det. Woelk asked Marsys Law if she would be willing to provide a statement. Marsys Law advised that she would.

Sex Crime stated that the relationship between Marsys Law and Mr. Toop began near the beginning to the middle of their senior year in 2017. Sex Crime stated that the relationship was initially started by Marsys Law. Sex Crime stated that Marsys Law thought that Mr. Toop was cute and began flirting with him. Marsys Law stated that shortly thereafter, Marsys Law and Mr. Toop became friends on Facebook and began messaging each other.

Sex Crime stated that after that, Marsys Law and Mr. Toop would flirt with each other via text message. Marsys Law stated that Marsys Law never showed her the messages but rather told her what they said. Sex Crime described the flirting messages as them telling each other that they were attractive. Marsys Law stated that after the flirting messages, sexual messages began. Marsys Law described these messages as them telling each other what they wanted to do sexually to each other. Marsys Law added that pictures were also sent to one another. When Detective Woelk asked what type of pictures did Mr. Toop sent to Marsys Law, Sex Crime stated that she had never seen them but added that Marsys Law had told her that Mr. Toop had sent pictures of his penis. Upon being asked if Marsys Law had sent Mr. Toop any pictures, Sex Crime stated that

Marsys Law had told her that she had sent him nudes. Sex Crime was unable to clarify what type of nudes were sent.

When Detective Woelk asked Sex Crime if the relationship between Marsys Law and Mr. Toop escalated, Sex Crime stated that there was one occasion that Marsys Law had told her about. Marsys Law Sex Crime stated that Marsys Law had told her that she had gone to Mr. Toop's classroom and they went into the closet together. Sex Crime stated that Marsys Law had told her that while in the closet she Marsys Law gave Mr. Toop oral sex.

When Detective Woelk asked Sex Crime if there were any other students that might have knowledge of the relationship between Marsys Law and Mr. Toop, Sex Crime gave the name Sex Crime Victims stated that Marsys Law and Sex Crime Victims were best friends at the time.

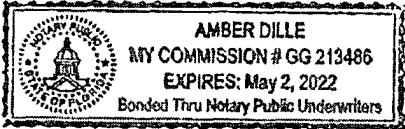
On 2/19/2020 Detective Woelk made contact with Sex Crime via land line. Upon being asked if she was privy to a relationship between a teacher and student at Charlotte High School when she attended school, Sex Crime advised Mr. Toop and Marsys Law. When Detective Woelk asked Sex Crime if Marsys Law had ever shown her text messages or pictures that she had received from Mr. Toop, Marsys Law stated that she did not see any text messages. Sex Crime added however that Marsys Law did show her a picture that Mr. Toop sent to her. Sex Crime stated that the picture was of Mr. Toop standing in front of a mirror wearing only a pair of white underwear. Sex Crime stated that the picture was of his body from the thighs up. Sex Crime Victims believed that Mr. Toop's face could be seen in the picture.

Based on the aforementioned facts, Detective Woelk is requesting that a warrant be issued for the arrest of Toop, Brendan William for the charge of Sexual Battery by person in custodial authority victim < 18 yoa contrary to the statute in such case made and provided, and against the peace and dignity of the State of Florida.
